Alicia Keys Meet and Greet Sweepstakes

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

SWEEPSTAKES DESCRIPTION:

The Alicia Keys Concert and Meet and Greet Sweepstakes ("Sweepstakes") will begin on November 29, 2012 and end on December 12, 2012 ("Sweepstakes Period"). This Sweepstakes will be conducted exclusively online. One (1) grand prize winner will be awarded two (2) front row tickets to see Alicia Keys perform live during her upcoming Spring 2013 tour in the city that is closest to the winner's hometown.

HOW TO ENTER:

Legal residents of the 48 contiguous United States who are 18 years of age or older residing within the metropolitan area of one of the participating radio stations (listed below) will be able to take part in this Sweepstakes. To participate in the Sweepstakes, participants must do the following:

- 1. Users will be driven from on-air promos to their local radio station's web site and instructed to click on promotional media that will direct them to the Sweepstakes entry page. Entrants must fill out all required fields to enter.

ELIGIBILITY RESTRICTIONS:
