

Faith Evans "When You Win You Will Have Tears of Joy" Sweepstakes

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

SWEEPSTAKES DESCRIPTION:

The Faith Evans *'When You Win You Will Have Tears Of Joy'* Sweepstakes will begin on September 17, 2012 and end on September 30, 2012. This Sweepstakes will be conducted exclusively online. One (1) grand prize winner will be awarded a two (2) night stay in New York City (for winner and one (1) guest), a \$1,000 shopping spree, and tickets to meet Faith Evans and see her perform live.

HOW TO ENTER:

Legal residents of the 48 contiguous United States who are (18) years of age or older residing within the metropolitan area of one of the participating radio stations (listed below) will be able to take part in this Sweepstakes. To participate in the Sweepstakes, participants must do the following:

1. Users will be driven from on-air promos to their local radio station's web site and click on promotional media that will drive them to the Sweepstakes entry page. Entrants must fill out all required fields to enter.
2. Participants must submit their entries through the web site of their local participating radio station. The participating stations include the following: WAMJ-FM, WWIN-FM, WQNC-FM, WMOJ-FM, WZAK-FM, WXMG-FM, KSOC-FM, WDMK-FM, KMJQ-FM, WTLC-FM, WRNB-FM, WFXK-FM, WKJS-FM, WFUN-FM, WMMJ-FM (the "Participating Stations")
3. Upon entering the Sweepstakes website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, to register for a chance to win.
4. All Internet entries must be received by 11:59 PM EST on September 30, 2012, or they will be void.
5. One entry per person per day, per email address during the Sweepstakes Period. Online entrants may only register through websites of participating radio stations in the metropolitan area where they reside.
6. In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.

ELIGIBILITY RESTRICTIONS:

1. The Sweepstakes is open only to legal residents of the 48 contiguous United States who are 18 years of age or older at the time of Sweepstakes registration and reside within the metropolitan area of one of the Participating Stations.
2. Employees of the Participating Stations, Radio One, Inc. (also "Radio One"), its officers, directors, subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, E1 Entertainment, their respective subsidiaries, affiliates, parent companies, members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and members of the households (whether related or not) of any of the above are NOT eligible to participate or win in this Sweepstakes.
3. Travel guest of grand prize winner must also be 18 years of age or older and a legal resident of the U.S. Winner and guest must each possess required travel documents (e.g. driver's license, or other valid government-issued photo I.D.) prior to departure and must travel on the same itinerary. Travel guest will be required to sign and submit all requested release forms along with the grand prize winner.
4. Persons who have won a prize in another sweepstakes or promotion of any kind from the Participating Stations within the thirty (30) day period immediately preceding the start date of this Sweepstakes are not eligible to participate. Only one (1) person per family or household (whether related or not) may win in any promotion from the Participating Stations during any thirty (30) day period.
5. Participants agree to abide with any applicable federal, state, local laws and regulations.

If your local radio station or geographic market is not listed above, then you are not eligible to enter the Sweepstakes or to be awarded any prizes for your participation. Radio One, Inc. and its affiliates shall not be liable for any claims by ineligible entrants.

PRIZES:

1. If a winner is unable to accept the prize, the prize will be forfeited in its entirety.
2. Prize package provided by E1 Entertainment will include the following:
 - Round trip coach airfare for two (2) to New York, NY;
 - A One Thousand Dollar (\$1,000) shopping spree (in the form of a Visa gift card). Gift cards are subject to terms and conditions specified by issuer;
 - Two (2) tickets to meet Faith Evans and see her perform, live in concert;
 - Hotel accommodations for three (3) days / two (2) nights, one (1) standard room, double occupancy.

Estimated Retail Value of the trip: Two Thousand Five Hundred Dollars (\$2,500). If the actual value of the prize trip is less than the stated approximate retail value, the difference will not be awarded in cash. If the winner or selected entrant is unable to be contacted within (10) days after being selected (e.g. drawing date), is ineligible, fails to claim a prize or fails to return completed and executed release forms and affidavits, if applicable and as required by Radio One, Inc, or if the prize notification or prize is returned undeliverable, that prize will be forfeited and if time permits, at the discretion of the sweepstakes sponsor / and or sweepstakes administrator, an alternate entrant will be selected as the winner by random drawing from among the remaining entries.

After completing the registration process, qualified entrants will be eligible for a chance to win the grand prize.
2. The grand prize drawing will take place on September 30, 2012. The winner will be selected by random drawing from among all eligible entries received electronically through the Participating Stations.
3. The grand prize winner will be notified by phone and/or e-mail.
4. The winner will be notified by a Radio One employee and provided with instructions regarding the trip, shopping spree, and concert.
5. All decisions made by Radio One management or any Sweepstakes Sponsor regarding any aspect of this Sweepstakes are final.
